## 2) Purpose & Objective:

The familiarization programme helps the independent directors not only to have greater insight into the Company's business but also contribute effectively in decision making at Board / Committee meetings.

#### 3) Overview of the familiarisation programme:

#### **Familiarisation upon Induction of new Independent Directors:**

- a. At the time of appointment, an appointment letter incorporating the role and duties, tenure of appointment, evaluation process, availability of Directors and Officers liability insurance, details regarding remuneration is given to the Directors.
- b. The Company conducts a well-structured induction programme for orientation and training of directors which includes one-to-one interactive sessions with the executive directors, selected business/functional heads.
- c. New independent directors are provided with induction kit which includes presentation on details about the Company, its subsidiaries, joint ventures, nature of industry in which the Company operates, business model of the Company, copies of Annual Report of last three years, Code of Conduct, Insider Trading Code, brief profile of other Board Members, Memorandum and Articles of Association, financial results of past one year, Committee Charters, Internal Audit Charter, policies such as Vigil Mechanism/ Whistle Blower, policy on related party transactions, roles, rights, responsibilities of independent directors etc.

The CEO is responsible for administration and compliance of this programme and authorised to amend this programme, in consultation with the Company Secretary, to give effect to any changes/amendments notified by the Ministry of Corporate Affairs or SEBI. The amended programme shall be placed before the Nomination and Remuneration Committee for noting and ratification.
